ITEM NO. 1: <u>004114 – Bid Form</u>

Submit bids on the attached Bid Form, revised to include Alternate 1 and to indicate the correct bid opening time.

ITEM NO. 2: Section 01 1000 – Summary of Work

Paragraph 1.03: The construction cost estimate is revised to \$150,000.

ITEM NO. 3: Section 01 2300 – Alternates

Add attached Section.

ITEM NO. 4: Section 07 5000 – Membrane Roofing

Paragraph 2.01.A: Refer to Section 01 2300 item above for mechanically fastened membrane alternate. Mechanically fastened roof systems shall be standard systems of the manufacturers listed.

Paragraph 2.01.C.4.d.(1): Minimum thickness shall be 0.0145 inch.

Delete paragraph 2.02.C.2. Cover board shall be mechanically fastened to deck in accordance with paragraph 3.03.D.

Add paragraph 2.02.G: Fasteners for Mechanically Attached Systems: As furnished by the membrane manufacturer; FM approved; with corrosion resistant coating.

1. Corrosion Resistance: Kesternich Cabinet test; 25 cycles with less than 15 percent red rust.

- 2. Pullout Resistance:
 - a. Concrete: Minimum 800 pounds.b. Metal Deck: Minimum 450 pounds.
- 3. Backout Resistance: Minimum 10 inch pounds.
- 4. Bonding Plate: 3 inch diameter, with recessed center and raised flat bonding surface; with Galvalume coating.

Add paragraph 3.04.A.1: Install mechanically attached PVC membrane in accordance with ASTM D5082. Induction weld membrane to bonding plates in accordance with manufacturer's requirements.

ITEM NO. 5: Sheet A-102 – Roof Details

Where metal roof deck is shown, conditions are similar at areas with concrete deck. Existing building drawings indicate metal deck at canopy areas and concrete deck at main building roof area.
