South Recreation Complex – Parking Lot Expansion and Pickleball Court

PROPOSED WORK:

Excavation of proposed pickleball court and parking lot expansion. Placement of provided millings. Installation of 12" 304 Stone Base for pickleball court. Storm Sewer and Swale installation. Placement of Topsoil and Restoration work. Embankment of spoils at adjacent areas.

- b) Compaction of Subgrade, Entire Project Area
- c) 11" Item 304 Aggregate Base over Geogrid, Pickleball Court Area

PROPOSED WORK:

Application of 1" of 411 Stabilized Crushed Aggregate to fine grade site for paving. This placed aggregate to be above previously installed 12" 304 Aggregate Base. Paving of 3" Asphalt Concrete Surface Course in two lifts.


- a) 1" of 411 Stabilized Crushed Aggregate placed and fine graded
- b) Two Course Asphalt Concrete, 3" Total Thickness
 - a. 1.5" Item 441 Asphalt Concrete Surface Course, Type 1 (449), PG64-22
 - b. 2" Item 441 Asphalt Concrete Surface Course, Type 1 (449), PG64-22

Note(s):

- 1) The Contractor shall construct or install the above work in accordance to the Contract Specifications.
- 2) Contractor shall schedule work with engineer a minimum of two weeks prior to work.
- 3) All pavement removals edges shall be cut with neat lines by use of a power carborundum saw or mill machine. Saw cuts shall be full-depth. Removals shall be made only to the extent provided in the plans, or as approved by the project engineer.
- 4) Pickleball Court to be paved within the time frame of <u>May 28, 2024 to June 14th, 2024</u> following installation of aggregate base per Project #4.
- 5) Site is accessible from Recreation Complex Drive on Starr Avenue Extension.






