The Bid Opening has been moved back to 2:00 pm on Thursday, April 25, 2024.

Delete and Replace the text for paragraph 1 of the **Notice to Bidders** with the following revised bid opening time:

- 2) Specification SECTION 01 23 00 ALTERNATES Section has been Revised
 - Replace with the attached revised section into the contract specifications for an additional alternate bid item #2.

ADDENDUM No. 3 REC LIGHTING PROJECT - PICKLEBALL COURTS & PARKING LOTS - 2024

DRAWING CHANGES

1) See Revised Drawing E1.1 (ADDENDUM NO. 3)

Replace Drawing E1.1 with the attached revised Drawing E1.1 (ADDENDUM NO. 3 4/19/24).

General recap of the changes:

- Eliminate two (2) parking lot poles on the west side of parking lot by drive.
- Two (2) parking lot poles on the east side of parking lot become alternate #2, including the feeders.
- Reroute of the base bid conduit
- Addition of 2 pole 20A breaker so each base bid parking lot pole has its own branch circuit.
- Conduit size revised for light pole feeders to be a minimum of ³/₄". (Contractor may use a larger size if they elect.)
- 2) Note: All conduit can be installed by either directional bore or trenching method. For either method, the contractor will be responsible for restoration of any disturbed areas, including final grading and seeding. For trenching through any future parking lot areas, contractor will be required to install granular backfill with proper compaction. Any trenching through the parking lot areas must be completed prior to July 1, 2024 before the 12" of millings are planned to be installed by separate contractor.
