The following additions, alterations, deletions and/or clarifications shall be part of the Base Bid as much as if they were originally included in the Contract Documents. This Addendum No. 1 is hereby made a part of the Contract Documents.

GENERAL INFORMATION

As a reminder, all bidders are required to be a plan holder to submit bids.

CONTRACT CHANGES

1) PROJECT BID FORM

Replace PAGES 7 and 8 in the Project Bid Book with the attached **BID FORM – REVISED PAGES 7 and 8 DATED 6/3/2025**.

a) Clarification for **REF No. 6 – ODOT Item# 608 - 6" Aggregate Walk**

The aggregate shall be ODOT 703.10 – Screenings.

b) Clarification for **REF No. 7 – ODOT Item # 608 – Curb Ramp, APP (Each)**

The unit price bid shall include detectable warning as detailed in the ODOT Standard Roadway Construction Drawing.

c) **Alternate Bid Item A-12** – Addition to the Base Bid unit price bid to install Ref No. 6 - 6" Aggregate Walk as a 6-inch concrete walk with a 4-inch aggregate base

Note: The alternate unit price bid will be **added** to the unit price bid for item Ref No. 6, if it is decided to proceed with installing as 6-inch concrete walk with a 4-inch aggregate base.
